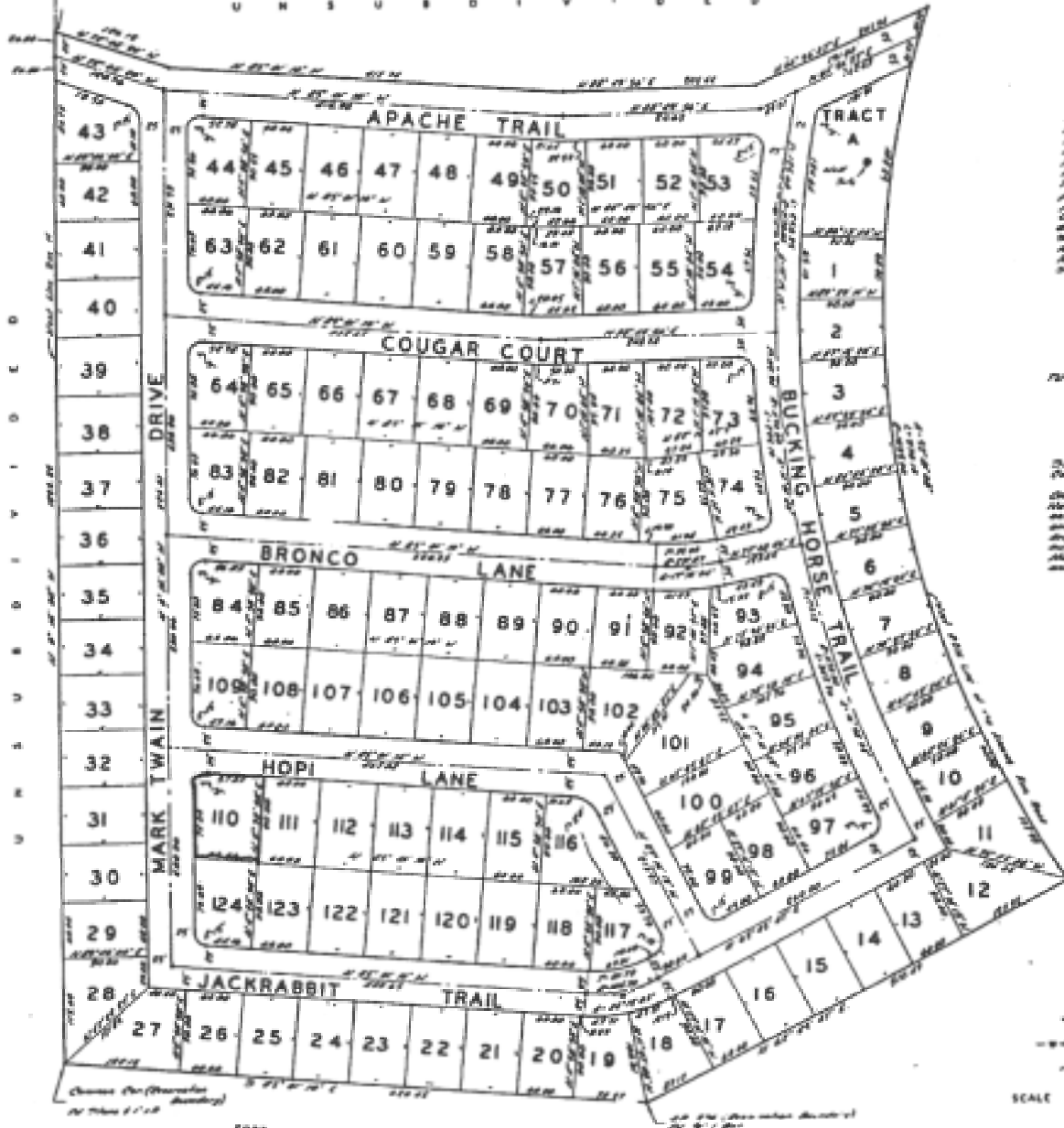


PINETOP COUNTRY CLUB MOBILE HOMES UNIT
